On behalf of Restore the Delta, we're writing to express our support for the application submitted to the California Energy Commission (CEC) by DNV Energy Insights USA Inc. (DNV). This effort plays a critical role in ensuring that California's transition away from natural gas infrastructure is just, community-informed, and equitable—especially for regions like Stockton and the greater San Joaquin County.

Based in the Sacramento-San Joaquin Delta since 2006, our organization works in the areas of public education, program and policy development, and outreach so that all Californians recognize the Sacramento-San Joaquin Bay Delta as part of California's natural heritage, deserving of restoration.

Their community-driven approach has fostered trust and demonstrated deep respect for local knowledge. We believe the project has strong support among similarly situated organizations and local leaders. Stockton is a region where high energy burdens, industrial expansion, and legacy underinvestment intersect—and we believe this project is well-positioned to help illuminate and address those structural challenges, building momentum for this type of equitable energy transition planning across California.

While Restore the Delta does not commit financial resources at this stage, we intend to provide continued engagement, staff time, and community convening support throughout the next phase. We are especially committed to helping identify locally tailored solutions that address Stockton's aging housing stock and infrastructure, as well as extreme climate vulnerability.

We look forward to continuing our partnership and strongly support the project's advancement through this funding opportunity.
